VI. Director's Report

Special Election:

The 2019 Special Election concluded on May 8, 2019, with the election of Master Trooper Robert Mire to serve in the unexpired term of the classified member of the State Police Commission. Ballots were counted by the Secretary of State's Election Division and in the presence of a Ballot Oversight Committee [as created per La. R.S. 42:1404(B)].

2019 Promotional Examination:

On May 7, 2019, State Police Commission staff administered the 2019 Promotional Exam. In accordance with State Police Commission Rule 7.22, the grades were consolidated with the previous year to establish one eligible list. Those employees registering for the 2019 exam were advised the rules provide that the most recent score shall determine their placement on the consolidated list and not necessarily their highest score. The Commissioners were provided with a list of the consolidated test results.

FY19/20 Budget:

The Commissioners were updated on the status of the Commission's FY19/20 budget as it is moving through committees and discussion in the 2019 Regular Session of the Louisiana State Legislature.

Strategic Planning:

The Commissioners were advised that it is time for the Commission's five-year strategic plan to be revised; a process that occurs every three years. A revised plan is being drafted in preparation for the July 1st deadline and will cover Fiscal Years 2020-2021 through 2024-2025. Commissioner Riecke asked to see a draft before it is submitted to the Office of Planning and Budget.

Expenditures:

The attention of the Commissioners was directed to the Commission's Monthly Expenditure Report that had been provided for its review. There were no questions or comments about the Report.

A motion was made by Mr. Crawford to consider adoption of Premium Pay for the Technical Support Officer job titles. The motion was seconded by Vice-Chairman Knapp. Following discussion, the vote was 5-0 against; the motion failed.

On motion duly made by Mr. Crawford, seconded, and passed; the Commission voted to approve the request as set forth on the agenda.

4. Request of the Office of State Police, for approval of Premium Pay for Trooper Tyler Latiolais in accordance with State Police Commission Rule 6.16(d), effective April 15, 2019 and to remain in effect for a period not to exceed 9 months. (Representative of the agency to be available to answer any questions of the Commission.)

Ginger Krieg, DPS Human Resources Director, appeared before the Commission to answer questions on the item.

On motion duly made by Vice-Chairman Knapp, seconded, and passed; the Commission voted to approve the request as set forth on the agenda.
