- 11.21.1 Leave of Absence With Pay Disabled Employee.
 - (a) An employee, after graduating from the State Police Academy, who in the performance of a duty which involves actual active policing, becomes disabled and is unable to perform their usual duties during the period of such disability, may be granted a leave of absence with full pay by the appointing authority with the prior approval of the Director. The initial duration of such leave shall not exceed six (6) months.

Leave granted under the provisions of Subsection (a) hereof shall not be charged against any leave balance the employee may have accrued.

- (b) Requests for leave provided in Subsection (a) shall be submitted to the Director in writing by the Department within forty-five (45) days from the date the disability began or prior to the expiration of the initial or any extended period(s) of such leave. Such requests shall include all information necessary to determine an employee's eligibility for such leave. Such requests will be considered and may be approved by the Director or the Commission.
- (c) If the leave requested under Subsection (a) hereof initially exceeds six (6) months, or later extends beyond the initial period, the Director shall submit such request to the Commission for its review and approval.

Leave provided for under this rule shall not exceed 4160 hours.

- (d) Where the affected employee has no other available leave, and the conditions for the leave provided for herein appear to be met, the Director may grant interim approval of requests which require Commission action.
 - Approval of requests made in accordance with Subsection b) hereof may be retroactive to the date the disability began.
- (e) The leave provided for herein shall be granted only upon condition of payment by the employee to the Department of all amounts, excluding medica, received by the employee in connection with Workers' Compensation benefits.
