There are significant differences between our commissioned aviators and other commissioned personnel in terms of the education, training, and experience required to successfully complete their respective job assignments. In the past, there was an adequate supply of experienced military pilot candidates due to the Vietnam War, but this is no longer true. An increase in offshore oil and gas activity has further complicated the problem of obtaining experienced pilots because those jobs far exceed the pay limitations of governmental positions.

Currently, pilot candidates must seek, obtain, and pay for this training. In fact, one of the requirements to become a State Police pilot is possession of a current FAA Commercial Fixed-Wing Pilot's License with an Instrument Rating or a Commercial Rotorcraft Pilot's License. The approximate cost of obtaining these licenses is \$20,000 and \$55,000 respectively. Once selected the pilot is cross-trained in the rating not previously obtained and given additional individualized instruction. To satisfy operational as well as FAA and insurance requirements, State Police expends approximately \$100,000 during the initial training of each pilot candidate.

In contrast to other law enforcement and state agencies, our pilots are required to operate solo and under instrument flight conditions, various makes and models of departmental airplanes and helicopters. This requirement increases the overall efficiency of our agency versus most other agencies which require their pilots to operate only one type of aircraft. Additionally, our pilots direct and assist in law enforcement operations which include: disasters, disturbances, hazardous materials spills, traffic enforcement, search and rescue operations, and aerial support of narcotics and other specialized operations. We currently have five pilots with plans to select and train two additional pilots in February 1998.

To overcome our selection and retention difficulties, we are seeking to revise the minimum qualifications for the State Police Pilot job series. Currently, the minimum entry level for all other specialized positions within State Police is a pay grade of SPS-19. The reevaluation of the job factor ratings will result in pay increases at all pilot classification levels. However, when compared to other specialized technical positions within State Police and other pilot positions within other state agencies, these recommendations do not exceed the industry standard. Should the currently proposed pay plan be approved then the corresponding pilot pay levels would be increased proportionately.

There are currently three commissioned Pilots, one Deputy Command Pilot, and one Command Pilot. If the plan is approved in January the total increase during this fiscal year, for the current number of personnel, will cost \$5,090 (pay increase x five months). Calculated on a full fiscal year amounts to approximately \$12,216 (pay increase x 12 months).
